The federal government allows self-employed workers selected by Québec to apply for a work permit to enable them to embark on their professional project in Québec more quickly, even if they have not yet received a decision regarding their permanent residence. The work permit is valid for a maximum period of two years, renewable if applicable, issued under the federal government's International Mobility Program.

Various requirements have been set out in order to be able to apply for this work permit, including proving that your temporary admission to Canada, in order to embark on your professional project, will create or maintain opportunities or social, cultural or economic benefits for Canadian citizens or permanent residents.

This appendix is intended to facilitate applying for a work permit and is an integral part of the of the application for permanent selection under the Self-Employed Worker Program.

Regardless of whether or not you want to apply for a work permit, you must submit this appendix, duly filled out otherwise your application for permanent selection will be returned to you.

If you are selected under the Self-Employed Worker Program, the Ministère will provide you with the documentation required to submit an application for a work permit to the federal government.
